Welcome to the November Newsletter from McGee who have been appointed by Northwood Investors and Platform to carry out both the Demolition and Construction works for the partial redevelopment and extensive refurbishment of 90 Long Acre.

Over the next four-week period the following activities will be taking place on site:

- Complete external scaffolding which provides additional acoustic and dust protection from the work face
- Progress with the top-down soft strip of the building
- Installation of 2nd tower crane, which will require a road closure on Endell Street on the 20th – 21st November
- Progressing with the top-down demolition
- Basement piling activities for new structural frames

A further newsletter will be issued next month, with an update on progress and other matters of interest regarding the works.

Key Upcoming Activities

- 1) Top-Down demolition to begin on the 12th of November 2021.
- 2) Basement piling activities for new structural frames to begin on the 12th November 2021.
- 3) Installation of 2nd tower crane, which will require a road closure on Endell Street on the 20th - 21st November 2021

Percussive banging from demolition equipment will be stopped outside of the hours above to allow respite for our surrounding neighbors. However understandably site activities need to progress and therefore other works on site will continue.

McGee have installed real time noise, vibration and dust (NVD) monitoring equipment in sensitive receptor locations around the site to monitor site works to ensure disturbance is kept to a minimum. Furthermore, to safeguard against any potential exceedances of agreed NVD levels with Westminster City Council.

Environmental Activities

We are pleased to report that the soft strip items removed from the site will be recycled and diverted from landfill where possible.

We are targeting 98% of recycling of waste from this site.


McGee have also looked to reuse or donate material on site where possible. This has included carpet tiles donated to a local rugby club, office partitions donated to a London based office fit out team and existing furniture at 90 Long Acre being reused in the welfare areas on site.

Vehicle Movement

All vehicle movements for demolition and piling works will continue to be planned and marshalled by experienced Traffic Marshalls onto site in line with the Traffic Management Plan agreed with Westminster City Council. Strict control of vehicle movements will be maintained to avoid clashes with local events and congestion for residents.
